B. NARTP Building 2

The Board will be asked to Authorize the Executive Director, with the assistance of Counsel to negotiate and execute an assignment of the ground lease from NARTP and a sub-lease to, and a Development Agreement with, Atlantic County 03, LLC for the development of Building 2 at the National Aviation Research and Technology Park.

C. Cape May Airport Redevelopment Project

The Board may be asked to authorize the Executive Director with the assistance of Counsel to negotiate and execute necessary agreements with Cape May County and the Cape May Brewery to fund the Authority's administrative costs and professional services agreements between the Authority and Stokes Architecture and Design in the amount of \$19,500.00 and C&S Companies in the amount of \$19,500.00 to develop a Conceptual Design and Cost Estimate for a new facility to be located on the Cape May County Airport and to further Authorize the two aforementioned professional services agreements.
